CIRCULAR 2/2013: REDETERMINATION OF MUNICIPAL BOUNDARIES: SECTION 21 PROCESS

Purpose of the Circular

As we approach the end of the 2011 – 2013 boundary review programme and, on behalf of the Municipal Demarcation Board (MDB), I would like to extend my appreciation to all stakeholders for valuable contributions and continued support throughout the boundary review process.

The purpose of this circular is to provide you with a list of all cases the Board has resolved to redetermine in terms of Section 21 of the Local Government: Municipal Demarcation Act, 1998.

The MDB would like to confirm that, in terms of the current constitutional and legal framework, the next local government elections will be held in 2016, following the National and Provincial elections, which are due in 2014. This requires that all changes to municipal boundaries need to be finalised in 2013 so that the voters' roll can be divided into municipal segments and wards can be delimited for the 2016 local elections.

Boundaries re-determined by the Board in terms of Section 21, Municipal Demarcation Act (Act 27 of 1998)

As indicated in previous circulars, the Board is at the final stage of redetermining the municipal boundaries, which include possible minor and technical adjustments, consolidations and medium scale boundary changes; and large scale amalgamation of two

or more municipalities as well as recategorisation of certain municipalities. At its 30 July 2013 meeting the Board resolved to re-determine the municipal boundaries as per the Annexure A. The Board has also included in this circular, cases that it has concluded and rejected. These cases are outlined in Annexure B. These cases will accordingly not proceed to Section 21 process.

The re-determination of the municipal boundaries as outlined in Annexure A will be published in relevant Provincial Gazettes, as required in terms of Section 21(3) and any person aggrieved by the determination, must within 30 days of publication submit objections in writing to the Board. The MDB expect to have all its redetermination to be published in relevant provincial gazettes from **8 - 12 August 2013**. The Board will therefore appeal to all the stakeholders and the public to submit written objections within the next 30 days following the date of publication of the notice. MDB will also communicate through the press and this information will also be available on its website.

Background on boundary redeterminations process

Stakeholders are referred to previous circulars of the Municipal Demarcation Board (MDB) in which the above-mentioned matters have been addressed on an ongoing basis.

In July 2011 the Municipal Demarcation Board (MDB) sent Circular 1/2011 to municipalities, and other stakeholders, to inform them of the programme and process for the re-determination of municipal boundaries. From September to November 2011 representatives of the MDB visited the 8 metropolitan and 44 district areas to explain the programme and process, and to encourage stakeholders to comment on proposals for the re-determination of municipal boundaries.

Stakeholders will recall that at the beginning of the boundary review cycle, the MDB tabled **558** requests for boundary changes during the **August- September 2011** visits to local and district municipalities. Some of these requests were received from local stakeholders in municipalities and, a significant number of requests, mostly technical requests, were initiated by the Board in cooperation with stakeholders such as the IEC and StatsSA, where the latter identified a number of municipal boundaries which require technical alignment to other boundaries or natural features. Municipalities, local communities and other stakeholders were requested to consider these cases as soon as possible, and to forward written comments under the relevant DEM-number, to the Board.

Furthermore, the MDB invited stakeholders to submit new proposals for boundary changes to the MDB not later than 15 December 2011. This date was later extended to **20 January 2012**. Some additional **470** requests for boundary changes were received by the end of this deadline and these were later discussed with communities, municipalities and other affected stakeholders in the second round of visits between May and July 2012. The total number of requests recorded for consideration by the Board was **1028**. The MDB used a classification to differentiate between different types of redeterminations from Type A, B and C which included but not limited to: the re-determination of the boundaries of certain metropolitan municipalities, the disestablishment/amalgamation of municipalities, the re-categorisation of municipalities, the establishment of new municipalities, and changes to municipal boundaries that affects a sizeable number of voters and significant geographic areas.

Consultation meetings and visits

The MDB embarked on an extensive consultation process during the May – July period which was inevitably extended to September 2012. In spite of formal consultative meetings arranged by MDB in conjunction with municipalities at district and metropolitan level, additional requests for meetings from individuals, communities, non-statutory and statutory organisations/institutions, including but not limited to: the Ministry of Cooperative Governance, Offices of the Premiers, Offices of Executive Mayors of Metros, MECs for

Cooperative Governance, Portfolio Committee on Cooperative Governance and Traditional Affairs, National and Provincial Houses of Traditional Leaders Traditional Authorities, PLCs, IEC etc., were considered and attended by MDB. During the consultation process and as noted in our previous circulars, the MDB placed tremendous emphasis on the importance of local consultation and public participation in the boundary redeterminations process.

The MDB always maintained that as a first step for a stakeholder wishing to request the MDB to change a municipal boundary is to consult the affected communities and the municipalities that will be affected by the proposal. Where traditional authority areas or boundaries, and/or magisterial district boundaries are affected, it is recommended that such authorities, the Provincial House of Traditional Leaders, and the relevant magistrate also be consulted. Once consensus has been reached with these stakeholders, the affected municipalities, and/or the MEC responsible for local government, can submit a request to the MDB to re-determine the boundary.

Section 26 process

At the end of the May-July 2012 consultative process, the MDB considered all inputs received on various proposals during and after consultations. Later in the year, the Board selected 204 cases for entry into the legal process and a total of 824 cases were rejected by the Board. On November 9, 2012, the MDB published a notice in terms of section 26 of the Local Government: Municipal Demarcation Act, 1998 in the national newspapers, followed by regional newspapers circulating in the area affected by the proposed boundary changes. The purpose of section 26 notice was to inform stakeholders and general public of the Board's intention to consider proposals for boundary redeterminations and invite views and representations from the public. The closing date for submission of views and representations in terms of section 26 was 10 December 2012. The Board received overwhelming responses on some major proposals but generally the feedback from municipalities and communities was rather disappointing.

Formal investigations and public meetings

After the closing date for section 26 submissions the MDB considered all views and representations submitted to it. In terms of section 27 of the MDA 1998, the MDB decided to hold public meetings on some cases and conduct formal investigations, mainly on major proposals.

1. Public meetings held from April – May 2013 and formal Investigations being conducted

The Municipal Demarcation Board (MDB) held public meetings on some major cases from April to May 2013 as per circular 1/2013. The purpose of the meetings was to provide an opportunity for the public to air their views and address the MDB on any issues of clarity related to the re-determination process and proposal/s. The MDB ensured that all issues raised were clarified and explained all options available to the Board in finalising the proposed re-determination.

The MDB would like to thank all stakeholders who attended and participated at the meetings. Most cases that were discussed during the public meetings were also subject to a formal investigation, as indicated in our previous circular. The formal investigation process was also considered mainly on major cases and findings of the investigation process together with the feedback of the public meetings were considered before final decisions were taken by the Board.

The Board would like to confirm the following arrangements:

The matters listed in the **Annexure A** needs to be finalised urgently, and the affected stakeholders need to prioritise attention to them, please.

In the current period, the MDB will formally determine or re-determine municipal boundaries, and the publication of section 21 notices in Provincial Gazettes to invite objections, will be published in the relevant provincial Gazettes from **8 - 12 August 2013**. The closing date for objections will be **16 September 2013**.

Your attention is drawn to section 21(4) of the Demarcation Act, 1998, which places the onus on any aggrieved person to submit written objections to the MDB within a period of 30 days. No extension of this period is legally possible, and any objection received after the closing date will be rejected.

All objections should be based on section 24 and 25 of the Demarcation Act, 1998, and in the case of metropolitan areas, also Section 2 of the Structures Act, 1998.

The MDB will consider all objections received during the objections period, and will then either confirm, vary or withdraw its determination.

The MDB's final decisions in this regard will be gazette in terms of section 21 (5) of the MDA by **30 September 2013**.

Stakeholders are also urged to complete the attached Annexure C (Objection Form) in response to the section 21 notice and submit this to the MDB by via fax no: 012-3422480; Fax to email: 0864008191 or by e-mail: info@demarcation.org.za within 30 days of the publication of this notice.

Details of this notice can be downloaded from the MDB website (www.demarcation.org.za); can be obtained by sending an email to MDB on this email address: info@demarcation.org.za or alternatively, stakeholders can obtain a copy of the notice from the local municipality offices once copies have been circulated by the MDB.

Cases confirmed or varied by the Board, will then be forwarded to the IEC to publish its views in terms of section 23 of the Act. If the Electoral Commission is of the view that the boundary determination: (a) will affect the representation of voters in the council of any of the municipalities affected by the boundary determination, the determination takes effect from the date of the next election in the area concerned; or (b) will not materially affect the representation of voters in such council, the determination takes effect from a date determined by notice in the relevant Provincial Gazette by the MEC for local government in the province concerned.

The Electoral Commission, within 60 days after having received the particulars from the MDB, must make known its view by notice in the relevant Provincial Gazette. The MEC for local government in the province concerned must publish the notice on which the boundary change become effective, within three months of the date of the notice published by the Electoral Commission.

Further changes to municipal boundaries

Stakeholders must note that the Board will consider NO further changes to municipal boundaries. All new cases submitted to Board will be referred back to the applicants for compliance with section 22, 24 and 25 of the Demarcation Act, 1998, and re-submission after the 2016 local elections.


