CIRCULAR 4/2020: DELIMITATION OF WARDS 2019-2020: REVISED PROGRAMME FOLLOWING THE DECLARATION OF STATE OF DISASTER AND LOCKDOWN TO PREVENT THE SPREAD OF CORONA VIRUS (COVID-19).

PURPOSE

1. To advise on the revised ward delimitation programme following the declaration of state of disaster and lockdown to prevent the spread of Corona Virus (Covid-19).

INTRODUCTION AND BACKGROUND

2. In view of the declaration of a state of national disaster in the country by the President on 16 March 2020 and the subsequent declaration of the national lockdown which commenced on 26 March 2020, the MDB published Circular 3 of 2020. In the circular, the MDB communicated that it **has suspended all outstanding public consultation meetings until further notice.**

3. Throughout the ward delimitation public consultation process since February 2020, the MDB has been implementing a two pronged approach. Besides, hosting public meetings, the MDB has allowed members of the public to simultaneously also make written submissions. The due date for written submissions was extended from 30 April 2020 to 15 May 2020 as outlined in Circular 3 of 2020,
4. The MDB has considered the overall impact of the suspensions on the overall ward delimitation programme. Consequently, a revised programme was developed with new timeframes as indicated in the table below.

REVISED WARD DELIMITATION PROGRAMME 2020

5. The programme divides municipalities in the country into two groups i.e. Batch 1 and Batch 2 depending on the stage at which they are in the ward delimitation process.

BATCH 1: WARD DELIMITATION PROGRAMME FOR MUNICIPALITIES WHERE PUBLIC MEETINGS HAVE ALREADY BEEN COMPLETED (SEE ANNEXURE A).

6. The MDB has extended the period for submission of written submissions from 15 May 2020 to 31 May 2020 for Batch 1 municipalities as listed in **Annexure A**. Members of the public and all stakeholders who have not yet submitted their written submissions have until then to submit written submissions to the MDB on how they would want their wards to be configured.
7. **In June 2020, the MDB will consider all written submissions** (Batch 1) and determine wards for publication in provincial Gazettes.
8. **All wards will be published in provincial Gazettes in July 2020.** Anyone aggrieved by the wards as published will be allowed 14 days to submit written objections.
9. In **August 2020, the MDB will consider all objections received** (Batch1) determine and publish final wards in provincial Gazettes.
10. Final wards for Batch 1 will be **handed over to the IEC by end of September 2020.**

BATCH 2: WARD DELIMITATION PROGRAMME FOR MUNICIPALITIES WHERE PUBLIC MEETINGS WERE SUSPENDED (SEE ANNEXURE B).

11. In view of the uncertainty of the circumstances regarding the spread of the Corona Virus in the country, the MDB came up with two scenarios on how public consultations for Batch 2 municipalities will be rolled out:
- a. **Scenario 1:** In case the circumstances regarding the management of the spread of Covid-19 do not improve and the level of lockdown or conditions thereof are not adjusted to a level that will allow for gatherings or public meetings by 31 May 2020, **the MDB will consider all outstanding public meetings cancelled.** However, the period for making **written submissions for members of the public in Batch 2 municipalities will be extended to 31 July 2020.**

- b. **Scenario 2:** In case by 31 May 2020, the situation has improved and the level of lockdown is adjusted to allow public gatherings, ward delimitation public meetings for municipalities in Batch 2 will be rescheduled for June 2020. The nature of these meetings will be subject to the Covid-19 regulations, determinations and restrictions imposed by the Covid-19 National Command Council. In this regard, these meetings will most likely be different from the normal public meetings e.g. number of attendees might be limited, venues might have to be pre-disinfected etc. The MDB will engage affected municipalities on these when the time comes.
12. In order to prepare for public meetings for June 2020, the MDB has revised the schedule of public meetings as reflected in **Annexure B**. In this regard, all Batch 2 municipalities are requested to urgently **re-confirm the availability of venues by not later than 20 May 2020** by sending an email to Mr Fazel Hoosen at fazel@demarcation.org.za. It should be noted that this is a tentative arrangement as these meetings will be subject to the conditions of the lockdown level at which the country or affected area will be by June 2020 (See paragraph 11b above.
 13. In August 2020, the MDB will consider all written submissions (Batch 2) and determine wards for publication in provincial Gazettes.
 14. All wards will be published in provincial Gazettes in September 2020. Anyone aggrieved by the wards as published will be allowed 14 days to submit written objections.
 15. In October 2020, the MDB will consider all objections received (Batch 2) determine and publish final wards in provincial Gazettes.
 16. Final wards for Batch 2 will be handed over to the IEC by November 2020.


CONCLUSION

17. Ward delimitation and public consultation information distributed to all municipalities and made available on the MDB website (www.demarcation.org.za) is still relevant for this process. Municipalities are still encouraged to facilitate community consultations, **in compliance with the social distancing requirements, determinations by the Covid-19 Command Councils' determinations (Lock down levels) and Covid-19 regulations** as they are published from time to time, to assist communities to not only understand the process but to make quality written submissions.
18. Municipalities are requested to assist the MDB and make available for the public all MDB ward delimitation information i.e. draft wards, submission forms, etc. If the **Covid-19 regulations (Lock down level) would at that time allow** for the meetings to take place, municipalities are also requested to invite members of the community to attend those public meetings. Regardless of the status as

determined by the Covid-19 regulations, written submissions will be accepted as indicated in paragraph 6 for municipalities whose public meetings have already been conducted (Annexure A) and paragraph 11a for municipalities whose meetings have not yet taken place (Annexure B)

19. As indicated in paragraph 12 municipalities in Batch 2 are requested to **reconfirm meeting venues by not later than 15 May 2020** by sending an email to fazel@demarcation.org.za.
20. We wish to assure everyone that the MDB is committed to meaningful citizen engagement and we urge all our stakeholders to assist the MDB to ensure that the ward delimitation process is successful.
21. The MDB also remains committed to the fight against the Corona Virus and will ensure that all regulations are adhered to.
22. We note that the programme could change at any time given the uncertainty brought about by the country's efforts in fighting against the spread of the Corona Virus. In this regard, the MDB will provide the necessary updates.
